

Background Check Form for Employment or Volunteering at District # 4005

Because the position for which are applying will require to provide care, treatment, education, training, instruction or recreation to children, Metro Deaf School requests the Bureau of Criminal Apprehension (BCA) perform a background check on you under Minnesota Statutes Chapter 299C.62.

As the subject of a Child Protection background check, your rights include:

- to be informed that Metro Deaf School will request this check for becoming or continuing as an employee or volunteer, and to determine whether you have been convicted of any of the specified crimes listed below, and
- to be informed of the BCA's response and obtain a copy of the report from Metro Deaf School,
- to obtain from the BCA any record that forms the basis for the report, and
- to challenge the accuracy and completeness of any information contained in the report, and
- to be informed whether Metro Deaf School has denied your application because of the BCA's response and not to be required directly or indirectly to pay the cost of the background check.
